MINUTES OF THE PLEASANT TOWNSHIP BOARD OF TRUSTEES REORGANIZATION and REGULAR MEETING JANUARY 4, 2024

5:30 PM

Pleasant Township Trustees met to elect officers for 2024 and conduct the Regular Meeting.

The meeting was called to order at 5:50 PM by Fiscal Officer James Snyder, acting as temporary chairman, with Trustees Joseph Kemmerer, Jason Miller and Rayna Moellendick present.

The floor was opened to nominations for chairman.

24-001 Mr. Miller nominated Ms. Moellendick as Chairman for 2024; seconded by Mr. Kemmerer. Voting: Kemmerer – yes; Miller - yes; Moellendick - yes; Motion passed.

Fiscal Officer turned the meeting over to Chairman Moellendick.

Minutes from the December 27 End-Of-Year Meeting were approved as submitted.

Fiscal Officer reported receipts of \$46,852.55 and payments of \$118,885.26 since the last meeting. All bills submitted were approved for payment.

Fiscal Officer submitted a reconciled bank statement for December. W-2 wage forms were distributed December 27. The 2023 Financial Report is complete and the published notice and meeting schedule appeared in the January 3 Eagle-Gazette. Temporary UHC insurance cards were printed and distributed January 3.

Mr. Dan Bower addressed Trustees regarding turning over the Tschopp Cemetery to the Township. He provided a 2-page summary of the cemetery history, approximate bank balance, a lot map and rules, regulations and procedures they have been following. Their attorney will handle the details of a transfer, Trustees will organize operational details and the Fiscal Officer will contact Local Government Services for guidance on establishing a Cemetery Fund.

Zoning Inspector reported no permits issued since the last meeting. The Health Department will send a letter to 5413 Cincinnati Zanesville Road regarding property cleanup and securing the building. Ms. Moellendick asked for an update on the Valley View signs as no work had been done when discussed earlier in Fall 2023. Mr. Purcell will follow up and provide an update

Chief Hutton reported on fire department matters.

He has contacted Hicks Partners for assistance in applying for an AFG grant for SCBA's. The department responded to 1,312 runs in 2023. There are 8 SCBA voice amplifiers that are broken. Repair of the 8 will cost about \$1,500 versus about \$600 each to replace. The OBWC PERRP report for 2023 has been completed and submitted.

Over the holidays, they have noticed evidence of alcohol use by users of the Community Room, in violation of the Terms of Use, and he asked how the situation should be handled. Trustees said that, if alcohol use is observed, room renters should be asked to leave. If they refuse, the Sheriff should be called.

Chief requested Trustee approval of adding a second search and rescue canine.

24-002 Mr. Kemmerer moved to approve adding a second search and rescue canine to the Fire Department; seconded by Ms. Moellendick. Voting: Kemmerer – yes; Miller - yes; Moellendick - yes; Motion passed.

The overhead medic door was repaired. The station truck has had charging issues and a new charger has been installed.

Jason Boyer reported for the Road Department. They are doing tree/brush trimming to clear road right-of way. Still waiting for a new auger to repair a salt spreader. Original estimated delivery was about 2 weeks. It is now about 6 weeks and the distributer and manufacturer cannot seem to locate the part.

Mr. Miller brought up the matter of Zoning Inspector pay. The matter was discussed and Ms. Moellendick did research with other townships to see where Pleasant Twp. was compared to other townships. Hocking and Rushcreek salaries were at \$7,600 based on hourly rate or % of permits toward salary. Walnut pays \$20 an hour and just came in under \$15,000 and Liberty pays at flat \$15,000 salary. Ms. Moellendick discussed getting to total 8% increase to be comparable salary to Walnut and Liberty which those townships have been very busy outside of regular meetings with solar, air B&B and zoning meetings. Mr. Miller suggested a salary of \$17,544 and Ms. Moellendick said this represented a 25% salary increase.

24-003 Mr. Miller moved to increase the pay of the Zoning Inspector to \$17,544/year; seconded by Mr. Kemmerer. Voting: Kemmerer – yes; Miller - yes; Moellendick - no; Motion passed.

Mr. Purcell said that he would retract his letter of resignation.
