Bids for furnishing bulk stone shall be quoted per-ton delivered to the Pleasant Township storage lot located at 3005 Lancaster-Thornville Road NE for the following materials:

304 Limestone

411/617 Limestone

#2/#4 Limestone

#8 Limestone

#57 Limestone

Type C/Type D rip rap

#### **Chip Sealing**

Bids shall be submitted on a unit cost basis for the following materials to be placed on roads within Pleasant Township as directed by Trustees.

MC-3000, MC-800, MWS-90 and RS-2 – per gallon applied.

#8 and #57 limestone – per ton applied.

- a) Bid bond for 10% of the total bid price
- b) Certificate of Qualification by the Ohio Department of Transportation as a prequalified contractor
- c) Affidavit of Personal Property Tax Liability per Section 5719.042 of the Ohio Revised Code
- d) EEO Certificate of Compliance
- e) Certificate of insurance

Bidders must comply with prevailing wage rates per Section 4115 of the Ohio revised Code.

An “Affidavit of Lien Release” must be completed and submitted with the final invoice.
